CiHRG Membership Application

- Membership eligibility, as defined in the **CiHRG** by-laws, is confined to those persons in the Central Illinois area who are actively engaged as Human Resource practitioners and/or who are members of the Society for Human Resource Management (SHRM). Please note that grandfathered members shall not be entitled to vote, hold office or chair a committee.
- Yearly membership dues, paid by the member's employer, are considered to be property of the employer. Upon termination or resignation from the dues sponsoring organization, CiHRG membership(s) may be transferred to an alternate employee within that organization. As a benefit to involuntarily dislocated association members, CiHRG will provide those individuals with a no-cost individual membership (meals not included), for up to three months or until the end of the current membership year, whichever is less. Individual memberships are not affected by this change.

The membership year for **CiHRG** will be from **January to December**.

The fee structure for the **CiHRG membership year** is as follows:

- \$45.00 annual dues plus \$12.00 for each meeting attended if SHRM member
- \$153.00 annual dues (includes meals and meeting) if SHRM member
- \$60.00 annual dues plus \$12.00 for each meeting attended if **not** SHRM member
- \$168.00 annual dues (includes meals and meeting) if **not** SHRM member
